

RICE COUNTY FAIR WORKING STOCK DOG TRIAL

JULY 19, 2009

THERE WILL BE TWO CLASSES -- BEGINNERS AND ADVANCED

THE TRIAL WILL START AT 1:00 PM IN THE HORSE ARENA AT THE FAIRGROUNDS

POINT / TIME TRIAL WITH SHEEP

BEGINNERS CLASS: HANDLER MAY HELP YOUR DOG. EACH OBSTACLE WILL BE WORTH 5 POINTS PER SHEEP TOTALLING 15 POINTS POSSIBLE. YOU MUST GET ONE SHEEP THROUGH AN OBSTACLE BEFORE MOVING ON TO THE NEXT OBSTACLE. THERE IS A 10 MINUTE TIME LIMIT ON EACH RUN. POINTS WILL BE CONSIDERED FIRST, TIME WILL BE TIE-BREAKER.

ADVANCED CLASS: HANDLER MUST STAY AT HANDLERS POST. EACH OBSTACLE WILL BE WORTH 5 POINTS PER SHEEP TOTALLING 15 POINTS POSSIBLE. YOU MUST GET ONE SHEEP THROUGH AN OBSTACLE BEFORE MOVING ON TO THE NEXT OBSTACLE. THERE IS A 10 MINUTE TIME LIMIT ON EACH RUN. POINTS WILL BE CONSIDERED FIRST, TIME WILL BE TIE-BREAKER.

CLASSES WILL RUN IN ORDER WITH HANDLERS MEETING BEFORE EACH CLASS:

- 1) ADVANCED
- 2) BEGINNERS
